speakers.


### Topics raised during the meeting:

- Seek an agreement to have Affiliate Society members registering for IETS annual meeting as IETS members and pay same rates.
- vi. Dr. Hosup Shim will send attendees addresses that might be attending from China, when he gets home.
- vii. Plan on regular (1 every other month) Skype meetings of AS and AC.
- viii. Promote the use of the IETS homepage as a conduit for Affiliate Societies.

### Anticipated goals are for fruition in 2017 to 2019:

- i. Compile a list of local and international speakers to bring cutting edge presentations.

Date of SBTE foundation: 18th June, 1985

**Number of members:** 175 members paid the 2016 annual fee; 755 members active in the system based on payment of at least one annual fee during the last 4 years.

**Primary interests of our members:** Reproductive biotechnologies applied in cattle, horses, sheep and goats, and related basic science.

**Topics of high interest:** Artificial insemination (great interest on Fixed Time AI), IVF, Embryo transfer, NT, Transgenesis and Reproductive Biology.

**Annual Meeting:** Usually happens in August. The scientific program includes, pre-conference workshops, plenary sessions, concurrent sessions (SBTE Technology and SBTE Basic Science), poster sessions and a student competition. Awards are given to the best abstracts in Basic Science, Applied Science and to the best Technical Report. In addition, awards are also given to the best scientist and practitioner of the year.

**Publication:** The proceedings of the Annual Meeting (talks and abstracts) are published in the journal "Animal Reproduction" (ISSN 1984-3143), together with the proceedings of the European Embryo Transfer Association (AETE). This important partnership started in 2014.

**Newsletter:** SBTE circulates a biannual Newsletter ("O Embrião" / "The Embryo") containing scientific and technical articles and information about the Society and scientific meetings. It has open access in our website and a printed version is sent by mail to all members.


**Sponsors:** Group of 12 affiliated companies paying month fees.

Re: Summary of Activities of the Canadian Embryo Transfer Association (CETA/ACTE)

CETA/ACTE recently held its Annual General Meeting on September 30, 2016 during the 2016 Joint Convention in St. Louis, Missouri. At our meetings, the executive committee was elected for the 2016-2017 year, Dr. David Hamilton, President, Dr. Luc Besner, Vice President and Dr. Guy Massicotte.

The CETA/ACTE membership numbers have remained stable throughout the past year, currently there are a total of 157 members, of which 73 are CETA/ACTE certified members.

The 2015 Canadian Embryo Transfer statistics were completed and submitted to IETS. A complete summary of the 2015 Canadian embryo transfer data is posted on the CETA/ACTE web site at: http://www.ceta.ca/et-activity.html

Our annual convention is held jointly with the American Embryo Transfer Association (AETA). The 2016 AETA & CETA/ACTE Joint Convention was recently held in St. Louis, Missouri from September 29 to October 1, and was a successful convention with high attendance. Both AETA and CETA/ACTE have a student scholarship program and CETA/ACTE awarded three students with a travel scholarship to attend the 2016 joint convention.

- The 2017 AETA & CETA/ACTE Joint Convention will be held in Orlando, Florida from October 26-28, 2017.
- The 2018 CETA/ACTE & AETA Joint Convention will be held in Montreal, Quebec from September 27-29, 2018.
- The 2019 AETA & CETA/ACTE Joint Convention will be held in Colorado Springs, Colorado from October 24-26, 2019.

The CETA/ACTE Certification program is species specific and is a prerequisite for the government approval program for embryo exports. Practitioners must be approved by the Canadian Food Inspection Agency (CFIA) in order to collect and freeze embryos for export from Canada.

A practitioner wishing to be certified by the Canadian Embryo Transfer Association must meet competency requirements and pass both written and practical examinations that are supervised by qualified embryo transfer and reproduction specialists. Certification is for a 3-year term, which is reviewed annually and includes satisfying continuing education requirements.

### AETE 2016 Report

- The object of the "ASSOCIATION OF EMBRYO TECHNOLOGY IN EUROPE" (AETE) is to facilitate the diffusion and application of knowledge relative to embryo technology in mammals by creating a forum for the exchange of scientific, technical and practical information at a European level and by organizing regular meetings encouraging everyone to participate: teachers, scientists, practitioners, technicians and students. Moreover the AETE aims to establish European technological solidarity, favourable to international exchange of embryos, by creating study groups and by striving to become a body to whom European veterinary and agricultural authorities may make proposals, and seek consultation.
- Actual number of AETE members is 210. AETE is administered by an elected board of governors (10 members) and by the General assembly during the annual meeting.
- The annual meeting in Europe is organized by the AETE board and the LOC beginning of September every year. The 32<sup>nd</sup> Scientific Meeting was held in Barcelona, Spain on the 9<sup>th</sup>-10<sup>th</sup> of September in 2016. LOC Chaired by Teresa Mogas, University Autonoma of Barcelona, Spain. Since 1993 an AETE Pioneer-medal is awarded and a special celebration during the meeting is dedicated to the medalist. This year medalist in 2016 was Prof. Henrik Callesen from Denmark.
- All invited papers and abstracts were published in the Journal of Animal Reproduction, join collaboration
  with the Brazilian Society of Embryo Technology (SBTE). This collaboration improves the scientific outcome
  of our annual meetings and opens the borders outside of Europe collaborating with other ET societies. Since
  last year the president or a Board member from each society is invited to the annual meeting of the other
  as representative.
- At the 2016 general assembly meeting it was proposed: (i) change of the word "Transfer" to "Technology", representing a broader number of biotechnological techniques related with embryo including transfer and; (ii) change of the name from "European Association of Embryo Transfer" to "Association of Embryo Technology in Europe" to match the AETE acronym. The same change was applied in French as "Association Européenne des Technologies de l'Embryon". Both propositions were favorably voted from our members.
- Next meeting (33<sup>rd</sup> scientific meeting) will be held on 8<sup>th</sup> and 9<sup>th</sup> of September 2017 in Bath, UK. LOC chaired by Brian Graham, EGG Tech.
- Regular statistical reports regarding the ET- activities in Europe for 2015 are provided; Responsible: Marja Mikkola (marja.mikkola@faba.fi) AETE Board member. Last year George Perry, Chair of the IETS Data Retrieval Committee together with Marja Mikkola manages to update and make friendly use the database collection program.
- The primary interests of our members are all relevant links to embryo technology and reproductive biology in cattle, horses, small ruminants, pigs, exotic and companion animals. Good cooperation exist on personally and administrative basis to many affiliated international and national organizations.

Now we are ready to join two societies, the west and the east societies, to build the new society "Japan Embryo Technology Society" (JETS) in 2017. Hokkaido will also become a satellite society of JETS and join the annual meeting of JETS. Therefore, the members of the JETS will be over 400 people. The society office is located at Kyoto University and is open to contact with the secretary Ms. Tomoyo Nishio (e-mail: jets@kais.kyoto-u.ac.jp).

The annual meeting has been held revolving at various local places in Japan, last one was in Tokyo and next meeting in Kyoto. The meeting has usually oral and/or poster session, and symposium and public program. Usually 150-200 members are joined to the meeting. In last 10 years, we have a practical workshop inviting veterinarians involved in commercial embryo transfer practice.
