Parent Committee on Companion Animals, Non-Domestic & Endangered Species (CANDES) Report to the IETS Board of Governors 1 June 2004

IETS CANDES Homepage

Our scheduled update (March, 2004) of the CANDES homepage was delayed somewhat (posted in May) because it was necessary to reconstruct each page in order to provide links back to the CANDES as well as the IETS homepages (according to the Board's suggestion in January 2004). We also have now posted our position statement on cloning CANDES which the Board approved in December 2003.

The Research and Regulatory Subcommittees both provided additional information for the Resource Manual and Import-Export Regulatory Information for CANDES, respectively. The Technology Subcommittee updated the contact information for suppliers of materials used for assisted reproductive technology (ART) applications in CANDES and have posted a list prioritizing the type of research that this subcommittee finds important for developing more efficient and effective ART procedures in CANDES.

The first draft of the Workbook on Biomaterial Transport and Disease Risks can be accessed as a pdf file under the Health and Safety Subcommittee. This was the outcome of the working meeting held by this Subcommittee on 21 - 23 November 2003 at the Henry Doorly Zoo in Omaha, Nebraska, USA. This subcommittee plans to hold another working meeting, tentatively scheduled for March, 2005, to further refine the workbook and to complete a comparative disease risk analysis comparing the potential dangers associated with transporting biomaterials versus live animals. Currently, regulatory officials do not distinguish between live, non-domestic animals and their gametes and in vitro produced embryos in regards to their requirements for transport. In fact, it appears that, somewhat illogically, they may enforce more stringent regulations upon gamete and embryo transport than upon the transport of live animals. By examining the comparative risks (potential and actual) associated with the transport of live animals versus animal products, it is hoped that a more rational basis for regulatory restrictions can be developed.

I hope you all have the opportunity to review our updated homepage and provide us with any comments or suggestions for improvement.
