Report to the IETS Board of Governors June 2009

2009 Workshop/Symposium

The 2009 IETS post-conference workshop/symposium on the "Implementation of Artificial Insemination in CANDES" was a success. There were approximately 120 attendants who mostly stayed for the majority of the day, and many who commented then and later that the event was the highlight of the entire conference. We had \$11,000 in sponsorship and \$6,470 was received from the registration fees for a total revenue of \$17,470 which was lower than our anticipated budget. The excess of \$648.16 was donated to the IETS.

There were 12 presentations and the speakers produced excellent peer-reviewed articles for the proceedings in a special issue of *Theriogenology* co-edited by Dr. Damien Paris and Dr. Gabriela Mastromonaco. This was a joint proceedings issue that contained articles from George Seidel's pre-conference symposium updating sperm sexing technology. There was an open discussion with the audience at the end of the workshop/symposium and the CANDES Research and Technology Subcommittee Chairs plan to prepare a summary article to be published in the IETS Newsletter sometime this year as well as an article to be published in *Reproduction, Fertility and Development*.

New Executive Committee Members & Mid-Year Meeting

We currently have 54 members in the CANDES Parent Committee and they were asked via e-mail for nominations for the position of Parent Committee Secretary and for Co-Chair of the Research Subcommittee. The names of the nominees were then sent to all members again and the votes were received.
